**MINUTES**

- I. **Call To Order** – Chairman Sayre called the meeting to order at 5:05 pm. Present were Sayre, Hull, Farrington, Christianson, Guisleman and Clerk Zimmerman.
- II. **Confirmation of Meeting Notice** – Zimmerman confirmed that the notice was published in the Edgerton Reporter, and posted in three public places along with the town website.
- III. **Presentation of 2008 Budget** – Sayre presented the proposed budget with the levy limit of \$503,260. (\$1.84/\$1000.00)
- IV. **Discussion** – Christianson suggested to decrease the towns savings account to possibly pay for the revaluation rather than raising the taxes to pay for it. Sayre stated he felt the township needs to have a savings account for emergencies, and future projects, such as the roads.
- V. **Adjourn – Motion** (Guisleman, Farrington) to adjourn at 5:45 pm. Carried 5/0.

- I. **Call To Order** – Chairman Sayre called the meeting to order at 5:45 pm.
- II. **Confirmation of Meeting Notice** – Zimmerman confirmed that the notice was published in the Edgerton Reporter, and posted in three public places along with the town website.
- III. **Review of Budget** – Zimmerman advised there was no written correspondence received for the budget.
- IV. **Public Discussion** – Citizen Brown recommended that we vote this proposed budget down, and not raise the levy limit. Christianson asked about the budget spreadsheet listing the 2008 assessed value. Zimmerman advised that should be listed as the 2007 assessed value because the town has not yet been assessed for 2008.
  - A. **Motion** (Citizen Andy Walton, Citizen Mike Rebman) to approve the tax levy of \$503,260 as presented by the Town Board for the 2008 Budget to appear on the 2007 tax bills pursuant to Sec. 60.10(a). Zimmerman asked for the eligible electors to raise their hands so that she could see who all were eligible to vote – 18 citizens raised their hands. Sayre asked for a show of hands for the electors who were in favor - 12 citizens voted yes; Sayre asked for a show of hands for the electors who were opposed - 6 citizens voted no. Carried.
- V. **Adjourn – Motion** (Guisleman, Farrington) to adjourn at 6:15 pm. Carried 5/0.
